



**OFFICIAL RULES  
2021 "KEEP THE JEEP!" DRAWING**

**I. GRAND PRIZE**

The winner will receive one (1) 2021 Jeep Wrangler (the "Vehicle"). No cash award or its equivalent will be given for the grand prize. Chandler Compadres ("Compadres") reserves the right to substitute a different model year or equipment package at its sole discretion.

**II. ENTRY**

The purchase price for initial entry into the Drawing is \$100.00 per ticket. By purchasing a ticket and entering the Compadres' "Keep the Jeep!" Vehicle Drawing, participants confirm that: (1) they meet all eligibility requirements of Section III; and (2) they agree to abide by these Official Rules. If a check or credit card used to purchase a ticket is dishonored by the bank, the entry corresponding to the dishonored payment will be declared invalid unless full payment is made prior to the Drawing. Any dishonored check or credit card will be considered an invalid entry and the Entrant will be notified by telephone or mail.

**III. ELIGIBILITY**

The Drawing is open to all individuals and legal entities who timely purchased an entry into the Drawing, fully comply with the Official Rules, and meet the following requirements:

- (1) If an individual, Entrants must be over the age of 18 or of such age as may be applicable to your relevant jurisdiction to participate in the Drawing;
- (2) the Entrant is a resident of the State of Arizona;
- (3) the Entrant is legally permitted to enter the Drawing; and
- (3) the Entrant (where applicable the relevant registered charities or charitable organizations) is legally permitted to receive the Vehicle from Compadres.

***The following individuals are not eligible and will be excluded from the Drawing:*** (1) Compadre Members, Active or Life Members, and their spouses and children under the age of 18; and (2) any owner, employee or agent of Auction & Event Solutions.

Any person or entity that purchases a ticket and meets the requirements of this section will be deemed a "Qualifying Entrant." Compadres reserve the right to withhold awarding the grand prize if the Compadres determine that any Entrant was not a Qualifying Entrant or otherwise eligible for the drawing at the time of the drawing, or the winning Entrant is unable to furnish sufficient proof of identification.

#### **IV. DRAWING**

Entries will be accepted until the earlier of: (1) the total number of tickets are sold; or (2) 12:00 p.m. on April 30, 2021. A random drawing of all qualified entries received will be held at 5:00 p.m. on Friday, April 30, 2021 using a web-based platform that will draw the winning Entrant at random (the "Drawing"). Compadres assumes no responsibility for unanticipated delays in holding the Drawing. Drawing entrants do not have to be present at the time of the drawing to win the Vehicle. Compadres will contact the winning entrant immediately following the drawing.

The Drawing will take place at 5:00 p.m. on April 30, 2021. The drawing will be conducted using an online raffle system Compadres hosted by Auction & Event Solutions. The names and contact information for all Qualifying Entrants will be entered into a database and each Qualifying Entrant will be assigned an identification number corresponding to their tickets. All of the identification numbers will then be pooled together and Compadres will randomly select one identification number (one Qualified Entrant) from the entire pool of Qualified Entrants using the online randomizer.

The Compadres will deliver possession of the Vehicle to the winner the following day, May 1, 2021, at 11:00 a.m. or another mutually agreeable time, at Rodeo Dodge, located 35747 N Ellsworth Rd, Queen Creek, AZ 85142, or as otherwise directed by Compadres.

#### **V. ODDS**

The odds of being selected to win the Vehicle depend on the number of qualified entries received for the Drawing. Compadres will only sell a maximum of 2000 tickets for the Drawing. Any tickets purchased or received after 2000 tickets have been sold will be returned to the buyer with a full refund. All tickets are sold on a first-come, first-served basis.

#### **VI. WINNER PUBLICITY**

By purchasing a ticket for the Drawing, all Entrants agree that, should they win the Vehicle, the Compadres shall have the right without additional payment or permission to use their name, age, town of residence and likeness for the purposes of announcing the winner of this Drawing and for other related promotional purposes in accordance with Compadres' privacy policy.

#### **VII. TAX IMPLICATIONS**

**THE WINNING ENTRANT SHALL BE RESPONSIBLE FOR ANY AND ALL FEDERAL, STATE AND LOCAL INCOME OR EXCISE TAXES, FEES, ASSESSMENTS, AND LIKE CHARGES ASSOCIATED WITH THE DRAWING OR PRIZES. THE VEHICLE WINNER IS ALSO RESPONSIBLE FOR ANY AND ALL STATE OR LOCAL LICENSE, TITLE AND REGISTRATION FEES ASSOCIATED WITH THE TRANSFER OF TITLE TO THE VEHICLE.**

The Vehicle will not be distributed until the Compadres have received from the winner any such documentation as may be required by the Compadres demonstrating that all applicable legal requirements have been met. Compadres will issue an IRS Form 1099 informational return to the winner of the vehicle.

Entrants, by participating (and the winner, by accepting a prize) release the Compadres, its members and their respective parent companies, affiliates, partners, subsidiaries, agents, representatives, sponsors, service agencies and independent contractors, and each of their respective directors, officers, partners, employees and agents, including advertising and promotion agencies, from any and all liability with respect to participation in the promotion, possession, use and distribution of the prize awarded.

## **X. DISPUTES**

Application and enforcement of these Official Rules shall be reserved to the sole discretion of the Compadres and any such determination is final. All Entrants further agree that any and all disputes, claims, and causes of action, arising out of or in connection with the Drawing, shall be resolved individually, without class action, any judicial proceeding shall take place in the state or federal courts within the State of Arizona, and any disputes shall be governed by the substantive law of the State of Arizona.

If any of the terms of the Official Rules are determined by any competent authority to be invalid, unlawful or unenforceable to any extent, such term, condition or provision determined invalid will be severed and the remaining terms, conditions and provisions which will continue to be valid to the fullest extent permitted by law.
